On this 18th Day of JULY in 2022, In the County of Riverside, under jurisdiction of the STATE OF CALIFORNIA, Be it ordered to any agent or officer of this court, [REDACTED] be apprehended, and held in remand of the Sheriff's custody, until such time as a Magistrate shall rule upon the defendant's due course, be that verdict, release or further remand.

Herefore, does this bind, and direct any agent of this court, Be they State, Local or Federal, to Pursue and Arrest the accused by all necessary legal means, bringing satisfaction to this Order.

The Defendant, [REDACTED] is accused and charged with the offense of FAILURE TO FOLLOW SEX OFFENDER REGISTRATION GUIDELINES (CA§290.08) a class C FELONY in the State of CALIFORNIA by failing to appear for summons duly ordered in RIVERSIDE COUNTY for the purpose of Sex Offender Registration review. LAW requires a reasonable bail be Set in the Amount of \$40,000** Said Bail shall be posted directly with the SHERIFF'S DEPARTMENT OF RIVERSIDE COUNTY. Eligibility for this preset bail is under the discretion of the Acting Authority of the Sheriff.

Et Etiam Should the accused Willfully remand themselves into the custody of the Sheriff of the above stated County, provisionary preset bond would be offered with surety of total, directly with the Sheriff in lieu of a CASH bond.

In the expressed interest of the public, Due to the sensitivity of the nature of the criminal history of the accused, the utmost expedience should be taken to ensure the safety and security of the people of the State of California.








